


Description

The Invesco BulletShares® USD Corporate Bond 2029 Index provides exposure to a diversified basket of US dollar-denominated, investment grade bonds, all with a maturity of 2029. The Index combines the precise maturity exposure of an individual bond with the diversification benefits of a broad basket of securities, and is expected to have a return profile similar to a held-to-maturity bond.

Methodology highlights

The Invesco BulletShares® USD Corporate Bond 2029 Index consists of US dollardenominated securities of globally domiciled corporate issuers that pay fixed amounts of taxable interest. Bonds must have a credit rating of at least BBB- (or equivalent) and a minimum outstanding par amount of \$500 million to be included.








